Title 22 Sec. 11.22, 11.28 SC 1327, 1329 Pol. 115, 117, 118	Attendance need not always be within school facilities. A student will be considered in attendance if present at any place where school is in session by authority of the Board; the student is receiving approved tutorial instruction or health care; the student is engaged in an approved and properly supervised independent study, workstudy or career education program; the student is receiving approved homebound instruction.
	For the purpose of carrying out certain requirements of extracurricular activities, the principal may excuse students to leave the building. However, no student may be excused from the school building without the permission of the principal or assistant principal.
Title 22 Sec 11.21	All absences occasioned by observance of the student's religion on a day approved by the Board as a religious holiday shall be excused, and no student so excused shall be deprived of an award or eligibility to compete for an award or the opportunity to make up a test given on the religious holiday.
SC 1546 Title 22 Sec. 11.21	The Board shall, upon written request of the parents or guardians, release from attendance a student participating in a religious instruction program acknowledged by the Board. Such instruction shall not require the child's absence from school for more than thirty-six (36) hours per school year, and its organizers must inform a Board of the child's attendance record. The Board shall not provide transportation to religious instruction.
Title 22 Sec. 11.23, 11.25	The Board will recognize other justifiable absences for part of the school day. These shall include medical or dental appointments, court appearance, and family emergency.
	The Board shall excuse the following students from the requirements of attendance at the schools of this district:
SC 1330	1. On certification by a physician or submission of other satisfactory evidence and on approval of the Department of Education, children who are unable to attend school or apply themselves to study for mental, physical or other reasons that preclude regular attendance.

Students enrolled in nonpublic or private schools in which the subjects and activities prescribed by law are taught, except that such students and students attending college who are also enrolled part-time in the district schools shall be counted as being in attendance in this district.
SC 1327	3. Students fifteen (15) or sixteen (16) years of age whose enrollment in private trade or business schools has been approved.

SC 1330	4. Students fifteen (15) years of age, and fourteen (14) years of age who have completed sixth grade, who are engaged in farm work or private domestic service under duly issued permits.
SC 1330 (c. 1844)	5. Students sixteen (16) years of age regularly employed during the school session and holding a lawfully issued employment certificate.

Issue written notice to any parent or guardian who fails to comply with the compulsory attendance statute, within three (3) days of any proceeding brought under that statute. Such notice shall inform the parent or guardian of the date(s) the absence occurred, that the absence was unexcused and in violation of law, that the parent is being notified and informed of his/her liability under law for the absence of the student, and that further violation during the school term will be prosecuted without notice.
SC 510, 1318	Repeated infractions of Board policy requiring the attendance of enrolled students may constitute misconduct and disobedience to warrant the student's suspension expulsion from the regular school program.
4. Guidelines	College Visitation
	Juniors and seniors are allowed a total of six (6) college visits over their last two (2) years. Students are required to secure an appointment with the college prior to the visit. Furthermore, they must bring a permission slip from their parents at least one (1) day prior to the visit. Upon return, the student must present a signed form from the college admissions office to verify the visit. Students who visit local colleges are expected to attend school on the day of the appointment and sign in or sign out at a reasonable time.
·	Early Dismissal Due to Illness
	Students will be excused by the school nurse or designated person according to the following criteria:
	1. An emergency card must be on file for every student in a building. It is the parent's responsibility to update information on the card if necessary.

- 2. Only authorized persons designated by parent/guardian on the emergency card will be called when parents cannot be contacted if it is necessary to exclude the student from school activities.
- 3. No student who is ill will be permitted to walk or drive home unless the parent/guardian gives permission to do so. This permission will be granted only after the parent/guardian is contacted by phone and at the discretion of the school nurse or designated person excusing the student.
- 4. Parents or designated persons must enter the school building to sign out ill students when they are excluded.
- 5. Exceptions to the above can be made at the discretion of the school nurse, after consultation with the building administrator.
